We reserve to ourselves the right from time to time and at all times hereafter to make all such alterations in or additions to this our Last Will and Testament as we shall think fit either by a separate act or at the foot hereof desiring that all such alterations or additions so made under our own signature shall be held to be as valid and effectual as if the same had been inserted herein.
