to put out to Lodge Land or Scur in the Bank of England
Exchequer, East India Company or upon Mortgage at
Interest or otherwise to receive and take in as he in his
discretion shall think fit the several and respective
shares of my said Estate and the profits and proceeds
thereof and of the said Trade or Employment herein
before given and bequeathed unto my said Children
respectively or any of them or any part thereof until
the same respectively shall become payable And that
my said Executor shall not be answerable for any of my
said personal Estate or the profits or proceeds thereof
for or touching the Lending Lending out or disposal
whereof which I have herein before given particular
directions or which he shall unavoidably or unwillingly

A Codicill to be added to the above written Last Will

The said Richard Watkins do hereby revoke and make
void such part only of the said Will as doth or may give to
my eldest son John Watkins to any share benefit profit or
advantage by carrying on of the Trade or Employment of a
Gambler from and after the first day of February which
will be in the year of Our Lord One thousand seven hundred
and fourteen, when his my said son John will have attained
the Age of One and Twenty years. But it is my Will and Desire
and I do hereby direct and appoint that the Executor named
in my said Will shall out of my other personall Estate then pay
and my said son John accept his share of the then value of
the household Goods and furniture Plate, Linen, Bedding
Dewer Brass and other Inplements of household and of the
said Gambler and the Tools and Inplements then belonging
thereto and mentioned in the said Will in proportion to his
such share as he shall be entitled to receive out of my said
other Estate in full satisfaction of all his my said son John's
share benefit profit and advantage out of or by the said Trade
or Employment after the said first day of February one thousand
seven hundred and fourteen and that always after that time
the said Trade or Employment shall be carried on as long
as my said Executor shall think fit for the sole benefit and
